# 2007 APacCHRIE & APTA Joint Conference Review



The 5<sup>th</sup> Asia Pacific CHRIE & 13<sup>th</sup> Asia Pacific Tourism Association Joint Conference, "Coming of the Asian Waves, Tourism & Hospitality: Education & Research", was held at Beijing Landmark Hotel in Beijing, China on 23-27 May 2007. Some 300 delegates from 21 countries attended the 5-day event hosted by the Beijing International Studies University.

A total of 224 papers and 46 posters were presented during the conference which generated and shared ideas for tourism and hospitality industry and education in Asia Pacific. All papers were included in the conference proceedings (CD-rom format) which were published and distributed at the conference.

Two keynote speeches were delivered during the Conference. The first one was themed "Post-visit 'Action Resourcing': Promoting and Supporting Tourist Adoption of Environmentally Sustainable Behavior," presented by Prof. Roy Ballantyne of University of Queensland. The second one focused on the theme of "Getting Ready to Serve the Olympic Games," presented by Ms. Penny Xiang of Beijing Organizing Committee for the Games of the XXIX Olympiad.

Two plenary sessions were presented during the conference and they were themed "The Asian Waves: Views from Young Tourism Scholars" and "Internationalization of Tourism Education" which were moderated by Prof. Kaye Chon of The Hong Kong Polytechnic University and Dr. Perry Hobson of International Centre of Excellence in Tourism and Hospitality Education (THE-ICE), respectively.

The conference was concluded with a banquet held in the Bauhinia Hall of Beijing Landmark Hotel and a complimentary tour to The Great Wall was held on last day of the conference for all delegates.

The next APacCHRIE Conference will be held concurrently with the Panel of Experts Forum in Perth, Australia. The 2009 APacCHRIE Conference will be held in Singapore. The International Centre of Excellence for Tourism & Hospitality Education (THE-ICE) http://www.the-ice.org will organise the 6<sup>th</sup> APacCHRIE Conference in Western Australia. # Birth of Asian Waves: History of APacCHRIE

# Birth of Asian Waves: History of APacCHRIE Kaye Chon

International CHRIE for many years endeavored to establish a strong Asian chapter of CHRIE, resembling that of Euro-CHRIE. There were several attempts over the years to found an Asian CHRIE chapter but with little success. Asia is a vast continent often with long flight distances between countries and it was not economically feasible for members to visit other Asian countries to attend a meeting. But this situation changed in more recent years with increase of mobility of population in Asia, thanks to the fast growing Asian economy and development of air transport infrastructures.

In May 2002, The Hong Kong Polytechnic University (PolyU) hosted the "Fourth Biennial Conference on Tourism in Asia: Development, Marketing and Sustainability" at the Miramar Hotel in Hong Kong. The Conference chairman Kaye Chon used the opportunity to convene an organizing meeting of Asia Pacific CHRIE. Two Executive Committee members of International CHRIE, Bob Bosselman and Agnes DeFranco, were in attendance of the organizing meeting and a dozen members of CHRIE residing in Asia attended the meeting. The meeting formally accepted the name of the new chapter "Asia Pacific CHRIE" or "APacCHRIE" in short. The meeting also elected Kaye Chon as the Founding President, Eliza Tse as Vice President, Ilsun Yang as Secretary and Carol Pido as Treasurer. The Chapter was duly integrated into the I-CHRIE governance structure during the annual Convention in Orlando, Florida in July 2002. Our aims and goals are to promote academic and research exchanges among hospitality, foodservice and tourism educators and industry practitioners in Asia-Pacific.

Inaugural conference of APacCHRIE was held at Lotte Hotel in Seoul, Korea, on 21-23 May 2003. Ilsun Yang at Yonsei University was instrumental in organizing the conference. Organizers of the conference did a marvelous job in staging the conference at the five-star Lotte Hotel in downtown Seoul with more than 200 international and domestic participants. But organizing the inaugural conference was not without challenges. Asia, particularly East Asia, was hard hit by an outbreak of SARS influenza in March 2003 and travel across the countries was extremely difficult. At the requirement of health ministry of Korea, those delegates coming from the so-called "SARS affected countries" had to produce a medical certificate and x-ray film to prove at the registration desk that they were "SARS free." A physician and nurse were on stand by at the registration throughout the conference. Thanks goodness, no one became sick during the conference and conference ended without an incident.

Then the President of I-CHRIE Fred Mayo flew to Seoul to address the inaugural conference. Kaye Chon, in his opening speech, reflected on the theme of the conference "Hospitality, Foodservice and Tourism Research and Education: The Asian Waves." He asserted that Asia had developed as the newly emerging global center of excellence in hospitality and tourism industry and the trend would continue in the following years. This phenomenon was referred to as the "Asian Waves" and hence the term Asian Waves was born at the conference.

Thereafter, the subsequent annual conferences were held in the wonderful cities of Phuket (2004), Kuala Lumpur (2005), Hualien (2006) and Beijing (2007).

With the tremendous effort from our President, Past Presidents, Board members, members and additional support from the members in Australia and New Zealand, the APacCHRIE Chapter made a petition to change its status from a Chapter to Federation in late 2005 and this was subsequently approved by the I-CHRIE Board at the Winter Board meeting in Washington in February 2006. APacCHRIE was formally recognized as a Federation within the I-CHIRE structure at I-CHRIE's 60<sup>th</sup> annual conference in Washington in July 2006. The newly established Federation consists of four geographical areas: East Asia, Southeast Asia, Oceania and Indian Sub-continent.

Within a short span of five years, APacCHRIE has grown rapidly and have over 100 members today from all over the region.

# First World Tourism Organization (UNWTO) and Pacific Asia Travel Association (PATA) Conference on Tourism Trends and Research

The Hong Kong Polytechnic University played a major role in the First World Tourism Organization (UNWTO) and Pacific Asia Travel Association (PATA) Conference on Tourism Trends and Research held in Guilin, China on 29 June - 30 June 2007. Professor Kaye Chon moderated the conference and Professor Haiyan Song presented a research report on the low cost carriers (LCCs) development in Asia Pacific at the conference.

About 150 delegates participated in this two-day event. The participants include officials at senior and operational levels from National Tourism Administrations and National Tourism Organizations especially dealing with marketing, promotion and human resource management. The conference also attracted a number of industry participants including tour operators, hotels, transport services, consultancy firms and media. Renowned scholars from major universities in China and abroad also attended the conference to share their latest research results related to the emerging tourism trends in Asia Pacific.

# Professor Kaye Chon of PolyU Honoured with Howard H. Meek Award



Professor Kaye Chon, Chair Professor and Director of School of Hotel and Tourism Management at The Hong Kong Polytechnic University (PolyU), was recently honoured by International Council on Hotel, Restaurant and Institutional Education (I-CHRIE) with the Howard H. Meek Award. Named after the first dean of hospitality school at Cornell University, Professor Howard H. Meek, the award has been annually presented since 1971 to one hospitality educator for his or her lifetime contributions and outstanding service to hospitality education. Prof Chon is the first recipient of the award from Asia Pacific in 36 years.

In presenting the award during I-CHRIE's 61<sup>st</sup> international conference held in Dallas, Texas, USA, I-CHRIE's President Professor Peter Jones, of the University of Surrey, commented, "during more than 20 years of teaching and research career in hospitality, Prof. Chon has made exceptional contribution to global hospitality education development through his leadership and research contributions."

Prof Chon is past President and Chairman of International Society of Travel & Tourism Educators and currently the First Vice Chairman of United Nations World Tourism Organization Education Council.

A former professor at University of Houston in the United States, Prof Chon joined PolyU in 2000. Under his leadership, PolyU's School of Hotel and Tourism Management was ranked fourth among the world's top hotel and tourism schools based on research and scholarship, according to a study published in the *Journal of Hospitality & Tourism Research* in August 2005. With more than 50 academic staff drawn from 17 countries, it is also the only training centre in Asia recognized by the Education and Training Network of the World Tourism Organization (UNWTO).



Following the success of the seven biennial conferences on Tourism in Asia held in Vietnam, Thailand, Hong Kong and Korea, the 8th Biennial Conference on Tourism in Asia will be held for the first time in Europe in 2008. 
### **Option B**

Featuring conceptual, empirical research, and applied research articles as well as book and software reviews, research notes, industry viewpoints, and conference reviews, JHTR keeps educators, researchers, and professionals in travel and hospitality up to date with the latest and most vital findings in the field.

### **Guidelines for Submissions to JHTR**

Manuscripts submitted to JHTR should be original contributions not under consideration for any other publication at the same time. If an article is under consideration by another publication, authors should clearly indicate this at the time of submission. Manuscripts should normally not exceed 7,000 words and must be written in English. Articles for the Viewpoints and Commentary, Publications in Review, and Research Notes and Industry Viewpoints sections should not exceed

3,000 words. The Rejoiners section of the journal is intended to publish short articles, commentaries, and rebuttals on the contents of JHTR. Authors should submit such contributions immediately after each issue of JHTR appears so that they are published in the subsequent issue.

- Manuscripts should be typed double-spaced, including references.
- Submit four (4) copies of each manuscript.
- Author's name should not appear anywhere except on the cover page (to preserve anonymity during the review process).
- All general editorial formats, abbreviations, use of statistics in text, citations, and references should conform to the Publication Manual of the American Psychological Association (4th edition).
- On the first page please include name of author(s) and title; author(s) note, including present position, complete address, telephone/fax numbers, e-mail address, and any acknowledgement of financial or technical assistance.
- The second page should feature the title of paper (without author's name), a list of no more than six keywords that define the subject matter, and a brief abstract of no more than 150 words substantively summarizing the article.
- Body: The text, with major headings centered on the page and subheadings flush with the left margin. Major headings should use all uppercase letters; side subheadings should be typed in upper and lowercase letters.
- Tables and Figures: Each table or figure should be prepared on a separate page and grouped together at the end of the manuscript. The data in tables should be arranged so that columns of like materials read down, not across. Non-significant decimal places in tabular data should be omitted. The tables and figures should be numbered in Arabic numerals, followed by brief descriptive titles. Authors should indicate in text where tables and figures should be footnoted under the table not in the title. In the text, all illustrations and charts should be referred to as figures. Figures must be clean, crisp, black-and-white, camera-ready copies. Please avoid the use of gray-scale shading; use hatch marks, dots, or lines instead.
- References: References should be typed double-spaced in alphabetical order by author's last name and should appear in APA style.
- Reference List Style: List references alphabetically, principal author's surname first, followed by publication date in parentheses. The reference list should be typed double-spaced, with a hanging indent, on a separate page. Do not number references. Be sure that all titles cited in the text appear in the reference list and vice versa.
- Authors of final manuscripts accepted for publication should provide both a hard copy of the final version of their article and a matching version on a 3.5-inch computer disk. Please send all manuscripts to Professor K.S. (Kaye) Chon, Journal of Hospitality & Tourism Research, School of Hotel and Tourism Management, The Hong Kong Polytechnic University, Hung Hom, Kowloon, Hong Kong.
